Circular from the Secretary of the Interior.

To Register and Receiver United States Land Office, and Special Agents. The following paragraphs appear in the report of the Secretary of the Interior, dated April 28, 1893, relative to the jurisdiction of public lands:

"The finding of large bodies of land beyond that allowed by law is illegal, and against the right of others who desire to settle on great tracts of the public lands."

"The Government will take proper proceedings against persons who have unlawfully encroached on the public lands, and who have failed to comply with the law."
