Washington, Dec. 9.—There is some consideration in silver circles about the capitol case. It is said that the combination includes a number of congressmen who have heretofore been prominent in opposition to the Pacific coast. They will be strong enough to prevent the combination from succeeding.

London, Dec. 9.—The cutting down of wages of the laborer, carpenters, and machine shop hands of the New York, New Haven & Hartford Railway company effects several thousand men. By its terms the laborers on the fifty track sections of the road lose 15 per cent all other employees except train men and conductors, are put on eight hours' day instead of ten. There are 8000 men in New Haven looking for work.
