

Report of the Grand Jury.
The grand jury presented to the court on Tuesday morning last the following excellent report. The leader thinks that this document will be fully endorsed by every proper loving citizen of the county.
PRO. USE. PROCEEDINGS.
Judge Second Judicial District, Washington County, Idaho.
We, the grand jury, have examined four (4) true bills and ignored seven (7). The latter we have referred to the county attorney for his action.
We have examined into the said bills and the proceedings of the grand jury and would respectfully submit the following:
We find that the county commissioners of Washington County have not yet filed their official report as required by law. We also discover that the county board is very defective and the collector's bond as filed is absolutely worthless. This officer collects nearly the whole revenue of our county, and has filed a bond in blank. Said blank bond is here with alcohol for your inspection. This blank bond appears to have been duly approved by the board of county commissioners.
We would respectfully call the attention of our county commissioners to their neglect in publishing the proceedings of the board as required by law (see Sec. 1729 revised statutes), also the summary reports of the auditor and treasurer, and the reports of the county may know what is done with their money. In this connection we would also recommend that the summary of warrants issued and served be paid from the consolidation of county dues to April 1st, 1897, as well as the summary of receipts and disbursements for some period, as made up by reports, be published, also the written report of same. We believe this important not only as a matter of information for the people of the county, but for the benefit of the citizens themselves. We find by this report that the assessor and collector have been very negligent in assessing the property of the county, and we believe the revenue of the county would be greatly increased if the duty of assessing was more carefully performed.
We have received various complaints relating to the delay of our auditor and treasurer in returning papers left for record. We must recommend said officer for such delay and would suggest that any future delays in this direction be laid before the next grand jury if the evil is not remedied.
We would most respectfully suggest that our district attorney exercise greater care and diligence in advising our board of county commissioners as well as bringing all law breakers to justice.
We have of necessity occupied much time in cases where no case was committed, but where the evidence, we believe, would fail to convict.
We believe the county attorney should see that the defective bonds are immediately corrected and the commissioners' bonds filed as required.
We have examined the county buildings and find that they are sufficient for present purposes.
Thinking the court and sheriff are anxious for corrections attended, we respectfully submit our report, as filed and ask to be dismissed.
