A statement from the staff says: The region we have been able to gain important ground. In general our troops hold the passes in Bukovina, along the line of the Suceava valley. On December 10 on the north and northwest fronts, the Serbian troops continued in pursuit of the fleeing enemy and occupied Daina Bata, Rogatzka and Kabanitzka. In the direction of Milanovatz and Belgrade, the enemy's attacks have been unsuccessful. Along this front the enemy has commenced to retreat and our troops are advancing.

On December 11 we took prisoners seven officers and 4770 soldiers, several of whom were wounded. We also captured three "quick-firers," eight field guns, a mountain mortar, multi-tion engines, several automobiles, a searchlight and a large quantity of war material.

PROHIBITION AND WOMAN SUFFRAGE

LOWER HOUSE OF CONGRESS WILL PASS ON BOTH PROPOSITIONS THIS SESSION.

WASHINGTON, Dec. 12.—You and many votes in the lower house of congress for consideration of proposals to submit woman suffrage and prohibition questions for constitutional amendment, was assured by the action of the rules committee today.

The prohibition question will be brought into the house Tuesday, December 22, and when it has been disposed of, woman suffrage will be taken up.

The rule for consideration of the prohibition constitutional amendment for nationwide prohibition was voted on unanimously by the committee. Its supporters and opponents were willing to submit it a record vote in the house. It provided eight hours of general debate and unlimited opportunity for amendment.

The rule for a vote on the Mandell woman suffrage amendment was voted on, four to three. Representative Foster, Democrat of Illinois, by joining the two Republicans and one Progressive on the committee, overcame the three Democrats who were opposed to it.

To Be Kept in Session. Chairman Henry declared one day would be allowed to each of the propositions and that the house would be kept in session until they were disposed of.

Representatives Campbell, Lincoln and Kelly, with Foster, outvoted the Democrats. Henry, Fou and Cantrell and Representative Caldwell, an other Democrat, declined to vote. The other Democrat, declined to vote. The suffrage vote would allow six hours of debate and unlimited opportunity for amendment.

It will be necessary for the supporters of both proposals to get a two-thirds majority for the adoption of the third majority for rules and procedure. The plan to begin consideration of the questions December 22 makes it apparent that the Democrats are determined to curtail the holiday recess as much as possible.

GRAND JURY WILL INVESTIGATE

Legal Steps Taken to Go to the Bottom of Things at the State House.

GOETHALS ASKS FOR WAR SHIPS

NEEDS DESTROYERS TO ENFORCE SHIPPING LAW OF PANAMA CANAL.

PANAMA.—Colonel George W. Goethals, governor of the canal zone, was impelled to suggest to the government at Washington that two swift American torpedo boat destroyers be stationed at the Panama canal, one at each end, by the recent activity of belligerent warships and colliers in the vicinity of the isthmian waterway.

The action of the Australian collier Mallina, which left Balboa without clearance papers, and the fact that this and other colliers have shown a disposition to disregard the canal zone shipping laws actuated Colonel Goethals to take a decisive measure to preserve the neutrality of the canal.

Supply for Fleets. Nearly a dozen of the colliers which have gathered in canal waters arrived without health certificates, and in several instances the ships sailed without clearance papers. It is presumed that the Australian collier, which conceals its identity in the vicinity of the Pearl Islands, which lie 60 miles southeast of Panama City.

The United States torpedo boat destroyers requested by the governor are expected to do patrol duty and to promptly overhaul any belligerent craft attempting to disregard the canal regulations.

Alleged violations of the canal shipping laws have, it is said, been the subject of complaint to Sir Claude G. Balfour, British minister to Panama, and also have resulted in causing orders to be given the fortifications to prevent un-neutral colliers remaining in ports on the canal zone in disregard of the orders of the canal authorities.

In the case of the collier Mallina, it is stated that she arrived without clearance papers or health certificates and with no coal or supplies. She attempted to buy three thousand dollars worth of supplies, consisting largely of articles intended for a Christmas dinner for a large force. She was refused the supplies and was ordered to depart because she refused to state her destination, as required by the canal zone laws. The collier Profilosius is pointed to as a similar case.

It is stated that there has been much wireless interference in canal water on the part of the night colliers which were recently in the vicinity of the canal and also by large warships which were reported to be within 25 miles of both ends of the canal.

WASHINGTON.—General Carranza's reply to the warning from the United States government that force would be used if necessary to stop firing into American territory by belligerent Mexican factions, reached the state department Sunday night but will not be made public until Monday. The warning was communicated to both General Carranza and Provisional President Obregon by a number of liberal internationalists. General Carranza replied by declining to notify the United States government of his troops are besieging General Huerta's garrison at Naco, to cease operations if necessary to stop firing across the border.

In a statement at Vera Cruz Saturday night, Carranza declared if the United States employed force to stop the firing at Naco, he will be considered an unfriendly act, notwithstanding the friendly motives cloaking the act. General Hill, Carranza pointed out, has been on the defensive at Naco and since his back was on the line "it is difficult to see how he could be responsible for the firing."

Another Victim of Stray Bullets. NACO, Mex.—Mexican "stray" fire added the fifty-second name to the casualty list on the American side Sunday. Mrs. Joe Martinez was hit in the back by a bullet from the algo border and pierced the wall of her home.
